

CALL FOR PAPERS

INTERNATIONAL SYMPOSIUM THE AUTHORITY OF THE SUNNA

16 March 2019, Sakarya, TURKEY

As one of the two normative sources of orthopraxy in Islam, the Sunna – constituting the practices of the Prophet Muhammad – plays an essential role in giving Muslims a certain common corpus. Yet, despite this commonality, the status of the Sunna is the subject of much theological debate today.

At the heart of this debate lies the issue of the binding nature of the authority of the Sunna as a normative source of Islamic theology and law. For example, is it a constitutive normative source of legislation, in other words is it an independent source of Islamic legislation in agreement with the Qur'an? Or is its role to be an explanatory framework (*mubayyina*) of the Text, in other words to explain, clarify or amplify an existing teaching of the Quran?

In order to explore, analyse, and discuss some of the seminal issues concerned, pave the way for greater understanding, and take important steps in the area, Sakarya University Theology Faculty and the International Institute of Islamic Thought UK (IIIT UK) are co-organising a symposium on THE AUTHORITY OF THE SUNNA to take place in March 2019.

- Prophet Muhammad's Actions and Appropriations
- The litihads of Prophet Muhammad
- The Classification of the Sunna
- Cultural Tradition and Customs in the Emergence of the Sunna
- The Nature of the Sunna as Sacred or Sacerdotal
